**AMENDMENT AND REINSTATEMENT TO  
INTERGOVERNMENTAL AGREEMENT  
On-Site Medical Care  
Tillamook Youth Correctional Facility and Camp Tillamook**

1. This is Amendment No. 3 to Agreement #14051, dated July 12, 2018, between the State of Oregon, acting by and through its **Oregon Youth Authority** ("OYA"), and **Tillamook County** ("Local Government"), each a "Party" and, together, the "Parties."
2. The Agreement had a termination date of **June 30, 2022**. The Agreement is hereby reinstated and amended as follows effective **July 1, 2022**: New Language is indicated by **bolding and underlining** and deleted language is indicated by ~~bolding and striking~~ unless a section is replaced in its entirety:

- a. Amend Agreement document, Section 3, titled Effective Date and Duration, as follows:

This Agreement is effective on **July 1, 2018**, or the date of the last signature, whichever occurs last ("Effective Date"), and terminates on ~~June 30, 2022~~ **June 30, 2026**, unless terminated earlier in accordance with Section 16.

- b. Amend Agreement document, Section 6, titled Compensation, Subsection 6.1 only, as follows:

**6.1 Not to Exceed Compensation.** OYA will pay Local Government **\$180.00 per hour**, four to eight hours per week, which includes travel, for completing Services under this Contract specified in Section 5.1. The maximum, not-to-exceed compensation, also referred to as "contribution amount" payable to Local Government under this Agreement, which includes any allowable expenses, is ~~\$180,000.00~~ **\$290,000.00**.

The amount paid to Local Government for services provided under this Agreement from July 12, 2018 until the day before the effective date of this amendment will not exceed ~~\$125,000.00~~ **\$180,000.00**.

3. Except as expressly amended above, all other terms and conditions of the Agreement are still in full force and effect. Local Government certifies that the representations, warranties, and certifications contained in the Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.

The Parties, by execution of this Agreement, hereby acknowledge that their signing representatives have read this Agreement, understand it, and agree to be bound by its terms and conditions.
