Public hearings held by the board are to provide the board an opportunity to hear from the public about a specific topic. Public hearings are therefore different regarding audience participation at board meetings.
- Commissioners shall be addressed by their title followed by their last name.
- Commissioners shall obtain approval from the chair before speaking or asking questions of staff, presenters, and public. As a courtesy, the chair shall allow an opportunity, by the commissioner who has the floor, to ask immediate follow-up questions.
- A majority of the board shall constitute a quorum and be necessary for the transaction of business.
- All board meeting notices are publicized in accordance with public meeting laws.
- All board meetings shall commence with the Pledge of Allegiance.
- The chair will utilize the gavel as needed to maintain order, commence and adjourn meetings, and signal approval of motions.
- The board reserves the right to recess to executive session as may be required at any time during these meetings, pursuant to ORS 192.660(1).
- The courthouse is accessible to persons with disabilities. If special accommodations are needed for persons with hearing visual, or manual impairments who wish to participate in the meeting, contact (503) 842-3403 at least 24 hours prior to the meeting so that the appropriate communications assistance can be arranged.

## **PUBLIC COMMENT**

- Providing public comment is an opportunity for constituents to be heard and express their views to the board.

- Comments are limited to one per person and per agenda item.
- Comments must be related to the agenda item(s) previously registered to comment on.
- The allotted time for public comments is two minutes per person; this time may not be allotted to another speaker. The chair may, at their sole discretion, further limit or expand the amount of time.
- The public comment opportunity is not a discussion, debate, or dialogue between the speaker and the board, which may or may not respond.
- Members of the public do not have the right to disrupt the meeting; the board may prohibit demonstrations such as booing, hissing, or clapping.
- Remarks containing hate speech, profanity, obscenity, name calling or personal attacks, defamation to a person, people, or organization, or other remarks the board deems inappropriate will not be allowed.
- Failure to follow all rules and procedures may result in not being able to provide public comment and/or being removed from the meeting.

When your name is announced, please come forward to the table placed in front of the dais and for the record, first identify yourself, area of residence, and organization represented, if any.





# Redeterminations

- Congress passed Omnibus bill on December 23, 2022
  - Unhitches redetermination process from public health emergency
  - Incentivizes states to begin redeterminations
- OHA will send Request for Information letters starting April 1, 2023
  - Members have 90 days to respond; 60 days continued coverage if no longer eligible
  - State has 14 months to complete the redetermination process (May 2024)
- Expect Redetermination process to be volatile




# Connections in the "Stream" of Health



# Health "Stream" Interventions





## Community Needs Assessment: secondary data

- Needs Assessment data points will include county population data, Medicaid data and survey results from collaborations with hospitals and Public Health in 2022:
  - People and Place (community served)
  - Opportunities for social and health care supports
  - Healthy Living Indicators: SDoH-E indicators across sectors (economic, education, built environment, social and community health)
  - Disease, Injury and Death: leading causes
  - Drivers of Medicaid Healthcare Costs: disproportionate, unmet, health-related needs
  - Needed supports by race, ethnicity, language, disability, age, gender, sexual orientation and other factors.



## Community Needs Assessment: primary data

- Narrative Story Collection: Participatory, equity focused, and trauma informed
- Amplify community and member voice at the decision-making table

To Whom it May Concern:

It is our pleasure to write a letter in support of the Home First Development affordable housing proposal in Manzanita, Oregon. This project will assist in fulfilling a critical need in the community for housing low-income families. According to the most recent Tillamook County Housing Needs Analysis, for every 100 families with extremely low incomes, there are only 27 affordable units available. This same analysis stated that one out of four renters in Tillamook County paid more than 50% of their income towards rent. We also acknowledge that because of institutional racism, People of Color, as well as immigrant and refugee communities are at higher risk for housing instability and homelessness. The need for culturally specific supports and access to affordable housing opportunities is critical to support this community.

If funded, this project will add 60 affordable units for families in Manzanita, Oregon. These units will feature a combination of size and configuration options and become a valuable resource to the low-income families and children in our community. The project seeks to support residents through onsite services that improve access to community resources. This project also seeks to provide an affordable housing option in the local community through engagement with community-based organizations to support site feedback, improve community awareness of the housing opportunity, and reduce barriers to accessing housing.

Through the work of the Tillamook County Housing Commission, Tillamook County has identified the lack of affordable and attainable housing as a critical issue in our communities. Manzanita and the surrounding areas are among those in our county with the greatest need for affordable housing, with only 12 units of subsidized housing currently in existence.

As a county government we do not directly build housing, and therefore we are exceptionally pleased to have Home First Development bringing much needed affordable housing to Tillamook County. We ask that you consider the application from Home First Development for funding to help us meet the need for housing in our community.
