

MODIFICATION #2 TO
PROFESSIONAL SERVICES AGREEMENT #6051
TILLAMOOK COUNTY AND NORTHWEST MEDICAL FOUNDATION OF TILLAMOOK
D/B/A ADVENTIST HEALTH TILLAMOOK
INMATE HEALTHCARE SERVICES

This agreement modification, hereafter "modification #2", is entered into by and between NORTHWEST MEDICAL FOUNDATION OF TILLAMOOK D/B/A ADVENTIST HEALTH TILLAMOOK (AHTM), hereafter "contractor" and TILLAMOOK COUNTY, hereafter "county", pursuant to ORS 203.010. The parties entered into a Professional Services Agreement on October 14, 2020. The parties intend this modification to modify their earlier agreement only as to their expressions herein. The mutual promises of each are given in exchange and as consideration for, the promises of the other.

2. AGREEMENT PRICE AND AMOUNT

The price for the services provided by contractor shall be ~~Three Hundred Sixty Thousand and 00/100 Dollars (\$360,000.00)~~ *One Million Two Hundred Ninety and 00/100 Dollars (\$1,290,000.00)*. *Included in the agreement price is Sixty Thousand and 00/100 Dollars (\$60,000.00) paid to contractor pursuant to Modification #1 for Licensed Clinical Social Worker services. These services remain outstanding.*

3. AGREEMENT TERM


The term or period of this agreement shall begin October 14, 2020 and end ~~January 31, 2022.~~ *January 31, 2024.*

All provisions of the underlying agreement not otherwise modified by this document remain in full force and effect and are incorporated herein by reference.
