Sara's visit to Washington DC to participate in National Library Legislative Day was successful. She represented rural and small libraries. Funding for museums/libraries has been reinstated.

Summer Reading starts June 12th! We will meet, or exceed, last year's record of 87 programs in a two-month period. Captain Book, the new mascot for Tillamook County Libraries, will make his debut. We are going to start offering coffee on Friday mornings beginning in June. Liquids are OK in covered containers in the library.

Planning for a Library District will start in the fall. Penny Hummel asked if we would like to do the survey in June again this year. Having the survey at the same time each year reduces one variable. The Strategic Plan Implementation Team will work on an update soon.

Commissioner Yamamoto, on behalf of the Board of County Commissioners, extended his congratulations on the successful passage of the levy. The group thanked him for the supportive piece in the Headlight Herald.
