This matter came before the Tillamook County Board of Commissioners on May 29, 2020. The Board of Commissioners, being fully apprised, finds as follows:

1. Under the emergency powers granted by ORS 401.305, on March 14, 2020 the Board of Commissioners signed Resolution #R-20-005 designating a State of Emergency within Tillamook County due to the spread of the Coronavirus (COVID-19).
2. On March 22, 2020 the Board of Commissioners signed Resolution #20-006 continuing the emergency and closing within Tillamook County all county, state, and federal parks, all county parking lots, beach access, and certain parking areas along road rights-of-way, and all county public boat launches to non-commercial users.
3. Since May 5, 2020 the Board of Commissioners has systematically opened certain Tillamook County facilities through several resolutions.
4. On May 27, 2020 the Board of Commissioners signed Resolution #20-016 continuing the emergency through July 6, 2020.
5. Although the emergency still exists, the Board deems it is appropriate to continue reopening county facilities in a safe and strategic manner.

NOW, THEREFORE, LET IT BE RESOLVED, that following are effective:

6. **Beginning May 29, 2020 at 12:00 p.m** the following day use areas owned by Tillamook County shall be open seven (7) days per week.
  - a. Twin Rocks Turnaround;
  - b. Happy Camp Beach Access;
  - c. Bay Ocean Peninsula; and
  - d. Anderson Hill Park.
7. **Beginning June 17, 2020 at 8:00 a.m.** all parks owned by Tillamook County shall be open to self-contained RV camping only in designated RV sites. Sites will be rented as reservation only with no walk-up rentals or extra vehicles. Tent camping is prohibited at this time. Park restroom and shower facilities will remain

closed and guests shall use their self-contained RV facilities.

8. All other county, state, and federal parks within Tillamook County remain closed.
9. All other county parking lots, beach accesses, and certain parking areas along road rights-of-way remain closed.
10. This resolution in the matter of opening certain Tillamook County parks shall remain in effect unless otherwise amended by the Board.
