Access in Tierra Del Mar During the) #R-20-028
COVID-19 Local State of Emergency)

This matter came before the Tillamook County Board of Commissioners on October 28, 2020. The Board of Commissioners, being fully apprised of the records and files herein, finds as follows:

1. Under the emergency powers granted by ORS Chapter 401, on March 14, 2020 the Board of Commissioners signed Resolution #R-20-005 designating a State of Emergency within Tillamook County due to the spread of the Coronavirus (COVID-19).
2. On March 22, 2020 the Board of Commissioners signed Resolution #20-006 continuing the emergency and closing within Tillamook County all county, state, and federal parks, all county parking lots, beach accesses, and certain parking areas along road rights-of-way, and all county public boat launches to non-commercial users.
3. Between May 5, 2020 and June 10, 2020, the Board of Commissioners signed seven (7) resolutions reopening certain facilities.
4. On August 26, 2020, the Board of Commissioners signed Resolution #20-023 opening the beach access in Tierra del Mar during the COVID-19 local State of Emergency until October 1, 2020 unless otherwise closed by the Tillamook County Sheriff or amended by the Board of Commissioners.
5. On September 2, 2020, the Board of Commissioners signed Resolution #20-024 continuing the emergency through November 3, 2020.
6. On September 30, 2020, the Board of Commissioners signed Resolution #20-026 continuing beach access in Tierra Del Mar through November 3, 2020 unless otherwise closed by the Tillamook County Sheriff or amended by the Board of Commissioners.
7. On October 28, 2020, the Board of Commissioners signed Resolution #20-027 continuing the emergency through January 2, 2021.
8. Although the emergency still exists, the Board deems it is appropriate to continue allowing beach access in Tierra del Mar.

NOW, THEREFORE, LET IT BE RESOLVED, that the following is effective immediately:

9. The beach access in Tierra del Mar remain open to the public seven (7) days per week.
10. The Board of Commissioners authorizes the Tillamook County Sheriff to close the beach access in Tierra del Mar at his sole discretion at any time in the interest of public safety.
11. This resolution in the matter of opening the beach access in Tierra del Mar shall remain in effect through January 2, 2021 unless otherwise closed by the Tillamook County Sheriff or amended by the Board of Commissioners.
