This matter came before the Tillamook County Board of Commissioners on May 26, 2021. The Board of Commissioners, being fully apprised of the records and files herein, finds as follows:

1. Under the emergency powers granted by ORS Chapter 401, on March 14, 2020 the Board of Commissioners signed Resolution #R-20-005 designating a State of Emergency within Tillamook County due to the spread of the Coronavirus (COVID-19).
2. On April 22, 2020, the Board of Commissioners signed Resolution #R-20-008 continuing the local State of Emergency through May 15, 2020.
3. On May 5, 2020, the Board of Commissioners signed Resolution #R-20-010 further continuing the local State of Emergency through May 31, 2020.
4. On May 27, 2020, the Board of Commissioners signed Resolution #R-20-016 further continuing the local State of Emergency through July 6, 2020.
5. On July 1, 2020, the Board of Commissioners signed Resolution #20-022 continuing the emergency through September 4, 2020.
6. On September 2, 2020, the Board of Commissioners signed Resolution #20-024 continuing the emergency through November 3, 2020.
7. On October 28, 2020, the Board of Commissioners signed Resolution #20-027 continuing the emergency through January 2, 2021.
8. On December 30, 2020, the Board of Commissioners signed Resolution #20-030 continuing the emergency through March 3, 2021.
9. On February 24, 2021, the Board of Commissioners signed Resolution #21-002 continuing the emergency through May 1, 2021.
10. On April 28, 2021, the Board of Commissioners signed Resolution #21-009 continuing the emergency through May 31, 2021.




11. The emergency still exists, and the Board deems it is necessary to extend the emergency.


