This matter came before the Tillamook County Board of Commissioners on June 30, 2021 at the request of Sheriff Josh Brown, Tillamook County Sheriff's Office. The Board of Commissioners, being fully apprised of the records and files herein, finds as follows:

1. The Tillamook County Sheriff's Office currently charges fees for each foreclosure, along with postage and advertising costs on all Writs of Execution in Foreclosure, in accordance with ORS 21.300 for the following items:
